## August 14,2023 UNAPPROVED

The Meeting of the Lilley Township Board was called to order by Supervisor Bouwens at 7:30 P.M.

**Public Comments:** Josh Weiser representative for the STR group read an email that addressed the last Planning Commission Meeting, and the future meetings, included the proposed actions that will be pursued if a mutual agreement cannot be reached, Robert Sergi finished reading the document.

Bob Doornbos also gave his opinion on the STR debate. Board declined to comment as they are waiting on Planning Commission recommendations.

Clerk's Items Thanked the Election Inspectors for their work in the August School Election, also commented on the new election laws for the upcoming elections next year regarding the 9 day prior voting, it looks like the County will take over those days if the Township would like, She is waiting on contract from the County and will have more information at that time. Mentioned that she feels that the BOR and ZBA should also get per diem raises, also Election workers, Board will think about this and discuss at the next meeting.

Trustee Anderson had a question of the cost to the Township to conduct our own early voting, Township would have to purchase another tabulator, and pay inspectors for 8 hours daily for 9 days prior to every election. Will be discussed more when we get contract from County.

Trustee's Items: Trustee Hoving has been working on a grant for the Fire Department and has not heard anything on it yet.

Trustee Anderson letter on his thoughts about many things going on in our Township and about our Board and their Labors for our Township.

Supervisor's Items: Supervisor Bouwen Asked to re-appoint Cynthia Israels and Anna Bonnett to the Planning Commission for another 3 year term.
